We are once again thankful and humbled to be leading the Center for Effective Lawmaking through a year of terrific successes and new opportunities.

The explosion of research work on topics of effective lawmaking this year has been remarkable. At every major conference and across all top journals in political science, work on effective lawmaking has found a prominent home. And the topics covered in those works have such practical implications and applications to those working in Congress and the state legislatures. We are grateful for the continuing hard work of our research assistants, post-doctoral scholars, faculty affiliates and their outstanding collaborators who have made this field of study so vibrant.

The work of translating those research findings into practical guidance for legislators and their staffs continues. We released a new wave of Legislative Effectiveness Scores for members of Congress, and are likewise making similar scores for every state legislator publicly available. We delivered our fully revised New Member Guide to every newly elected member of Congress, and are working on adapting that guide for use in the state legislatures. And we have dramatically expanded our Office Hours consultations with legislative staff in dozens of congressional offices.

We remain deeply grateful to the individuals and organizations who help advance these initiatives through giving of their expertise, time, and financial support. We believe that effective governing institutions are essential to preserving and advancing American democracy, and appreciate those who share our vision and who work to make it a reality.

New Legislative Effectiveness Scores

We updated our Legislative Effectiveness Scores at the end of the 118th Congress. Once again, these scores capture the advancement of both stand-alone and embedded legislation. Scores were released on the Center website in March of 2025, along with a robust media and distribution strategy. Similar to prior releases, we once again reached out to the offices of high-performing lawmakers to raise their awareness and helped them with quotes and information needed in their own press releases. We also added a media webinar in this cycle, which drew additional attention.

In total, these efforts were highly successful, as captured by various metrics. This includes about 80 news stories, 18 congressional press releases, and over 50 social media posts from official and related congressional accounts that highlighted the scores.

State Legislative Effectiveness Scores

Our State Legislative Effectiveness Scores capture legislators' activities over recent decades in state legislative chambers. Our initial research paper based on these scores won the American Political Science Association SPPQ Award for best paper on state politics and policy. The revised version of this manuscript was published in 2025 in the flagship journal for political science (*American Political Science Review*). We have made these scores available on our website, where they have been widely downloaded for use by scholars across the country. We are working toward regularly updating all scores at the end of each legislative term.

SMALL GRANT PROGRAM

The Center awarded seven research grants for a total of \$15,000 to scholars across the country. Research from these awards covers a variety of important topics in the legislative effectiveness field such as state lawmaking ("State Legislative Bill Topics"), electoral connections ("Do Voting Rights Matter? Legislative Consequences of Women's Suffrage" and "Electable Effectiveness: How Voters Interpret Different Measures of Legislator Effectiveness"), collaboration ("Central to Success: Measuring the Effect of Discursive Centrality on Legislative Effectiveness in Congress" and "Predicting Partnerships: Congressional Campaign Positioning and Legislative Collaboration"), and the economics of effective lawmaking ("Economic Inequality and Legislative Effectiveness in the U.S. Senate" and "Spoils of Incumbency: Effective Lawmakers as Lobbyists").

RESEARCH AWARD

In coordination with our 7th Annual Research Conference, we announced the 2025 Award for Best Publication on Effective Lawmaking. The award was presented to Fang-Yi Chiou (Academia Sinica) and Max Goplerud (University of Texas-Austin) for their article, "Effective Lawmaking Across Congressional Eras," published in *The Journal of Politics*. In this article, they examine how the legislative effectiveness of Members of Congress hinges on legislative institutions, and present findings on how certain factors – such as ideology and majority party membership - have dramatically changed over time.





The Center for Effective Lawmaking has continued to move significant research forward in the three main areas of identification, cultivation and accountability with a diverse and growing group of scholars. The CEL has expanded our research to also explore each of these three main research areas in regards to lawmaking effectiveness in U.S. state legislatures.

Current works in progress in these areas that are coauthored by Center Co- Directors Craig Volden and Alan Wiseman, CEL affiliates, and/or CEL small grant award winners, include the following:

- 1. Identification: Exploring the degree to which educational backgrounds establish the skills and networks that enhance lawmaking effectiveness, with differences across political parties. 






FACULTY AFFILIATES

We began our faculty affiliate program in the Summer 2018. Since then, our network has grown to thirty-four faculty affiliates, located at twenty-six colleges, universities, and think tanks across the United States. More than half are actively working on CEL research projects at present. Others are working to advance the CEL mission in other ways, including building connections and communicating relevant research findings.

STUDENT ENGAGEMENT

We continued our internship program, with both in-person and remote opportunities to allow for work flexibility. Two interns were brought on during the academic year and three for the summer of 2025, the latter of whom were chosen from a record number of applicants. Students were helpful in writing blogs, reviewing and editing reports and videos, and supporting CEL events and outreach efforts, which included research, generating lists, and utilizing their networks for CEL promotional purposes. This has been beneficial to the interns and the CEL as a whole since it enhances their professional experience while also allowing CEL staff to focus their attention on other important work. We are working to involve interns more actively in other areas, such as brainstorming communications strategy and technical assistance with major projects. In addition to the internships, we also employed ten research assistants at Vanderbilt University and the University of Virginia who assisted the Co-Directors with various assignments that have enhanced the work of the CEL and provided students with even more opportunities to learn about the field.

SIGNATURE EVENTS

We held our **7th Annual Research Conference** at Vanderbilt in June. The main sessions featured six one-hour-length presentations and discussions. Topics ranged from the link between redistricting and effective lawmaking, to the backgrounds of effective lawmakers, to the role of congressional staff in promoting effective lawmaking, to electoral effects from successful lawmaking, to coalitions between effective lawmakers and nonpartisan interest groups.

The conference was well-attended, drawing around 40 scholars from colleges, universities, and think tanks across the United States, as well as engaging students and faculty at the university. Additional highlights included a roundtable discussion of "Legislative Effectiveness in the Second Trump Administration," moderated by Alan Wiseman, with panelists including Shuwanza Goff (CEL Advisory Board Member), Brody Mullins (CEL Advisory Board Member), and Molly Reynolds (CEL faculty affiliate). We also announced the award winners for the fifth annual CEL Research Award.



In addition to this conference, Vanderbilt University hosted a small conference on effective lawmaking in the state legislatures, discussed in more detail below. The University of Virginia hosted Darrian Stacy (US Naval Academy and CEL faculty affiliate) to speak on "The Electoral Effects of Incumbent Wealth," and to meet with students and faculty members.

ACADEMIC EVENTS

The CEL organized a panel on effective lawmaking at the 2024 American Political Science Association Conference in Philadelphia, and hosted a dinner for panel participants and CEL affiliates. Research panels on effective lawmaking emerged organically at three other national research conferences this year – the Southern Political Science Association conference in Puerto Rico, the Midwest Political Science Association conference in Chicago, and the State Politics and Policy Conference in Boston. These panels and events are extremely important to spread awareness of research on effective lawmaking to the broader academic community and to build further connections among CEL affiliates.



In addition to these conferences, CEL advisory board member Thomas Wickham visited Vanderbilt University to meet with students in CEL Co-Director Alan Wiseman's undergraduate course on "The Legislative Process." While on campus, Mr. Wickham also met with several members of the Vanderbilt faculty and Administration, as well as Vanderbilt graduate students and post-doctoral fellows. Throughout the year, we also hosted speeches and class visits, featuring current and former state legislators and members of Congress, including Congresswoman Jen Kiggans (R-VA) and Delegate Sally Hudson (D-VA) at the University of Virginia.

COMMUNITY EVENTS

Additionally, we held our First Annual Research Conference on Effective
Lawmaking in American State Legislatures at Vanderbilt University in February.
The main sessions featured seven one-hour-length presentations and discussions.
Topics ranged from bipartisanship and effective lawmaking across parties in state legislatures, to geographic and ideological patterns of legislative collaboration and effectiveness, to gender differences in approaches to lawmaking, to progressive ambition of effective lawmakers, to the role of interest groups in setting state policy agendas. Additional highlights included a dinner discussion between Alan Wiseman and Bill Purcell (former Majority Leader in the Tennessee House).




CONVERSATIONS WITH LAWMAKERS SERIES

We added four videos to our "Conversations with Effective Lawmakers" interview series. Specifically, we interviewed West Virginia House Speaker Roger Hanshaw (R-WV, Dec. 2024), U.S. Rep. Gus Bilirakis (R-FL, April 2025), New Mexico State Senator Mimi Stewart (D-NM, May 2025), and New York Assembly Member Amy Paulin (D-NY, July 2025). In addition, we have compiled organized short clips drawn from our Conversations series highlighting various habits of highly effective lawmakers on the CEL website that are available for faculty around the world to use in their classrooms.

We have continued to build relationships with journalists focused on lawmaking on Capitol Hill. In addition, we have begun more concrete conversations with potential partners to help promote the dissemination and use of our Legislative Effectiveness Scores and related research findings.

Partnerships

The Center continued its many relationships with partner organizations on a number of fronts, all in alignment with the CEL mission. We continue to work toward systematizing these partnerships to build upon past successes.

We maintained existing partnerships for congressional staff training with the Brookings LEGIS Fellows and APSA Congressional Fellows Program. We provided New Member Guides to enhance the orientation programming, through the House and Senate party leadership offices, the House and Senate Democratic and Republican Policy Committees, the House Chiefs of Staff Association, the Congressional Research Service, the Congressional Management Foundation, the Congressional Institute, Stennis Congressional Staff Fellows, and various congressional caucuses. Our guides were also included in the materials distributed during the orientation programs at Harvard's Kennedy School.





With respect to institutional reforms and support within Congress, we've continued to take part in meetings and initiatives with the Fix Congress cohort of good governance organizations and to work with the Committee on House Administration and its Subcommittee on Modernization and Innovation. We also offered the lead commentary "Five Lessons for Lawmakers from Trump I" as part of a discussion series in the Niskanen Center's Hypertext forum in January 2025.

We're expanding connections at the state legislative level as well, including in collaborations with Lyceum Labs and the Leading to Govern Network (including Future Caucus, New Deal Forum, New Politics Leadership Academy, and the Rainey Center). The network has been supportive in opportunities to advance the missions of one another's organizations and in collaborative projects.

Based on the findings from our research on lawmaking effectiveness in the states, we were invited to present our insights to lawmakers in Michigan and in Nevada. In Michigan, we partnered with the Legislative Leadership Program of Michigan State University to present insights for lawmakers in the state's House of Representatives and Senate. In Nevada, we partnered with the Guinn Center from the University of Nevada-Reno to serve as the keynote speakers at their Gallagher Dialogues, attended by more than half of the members of the state legislature, as well as the governor and others in the executive branch.

STAFF EVENTS

Through approximately monthly visits to Capitol Hill, we have been significantly expanding our interactions with congressional staff, lawmakers, good governance partners, and media. Each of these connections has helped us to identify better ways to connect with congressional staff.

In May of 2025, we started planning a joint briefing with the Program for Legislative Negotiations from American University, and conducted this joint

briefing two months later with over 100 congressional House and Senate staff in attendance. We also held in-person meetings with former and current members of the U.S. Congress who work on congressional modernization issues, as well as congressional staff representing personal, committee, and leadership offices in the U.S. House and Senate. In total, CEL connected via electronic/virtual and in-person meetings with over 79 House and Senate congressional offices in the past year, to help advance our many programs on Capitol Hill.



Funding Updates

Thanks to the generous financial support by the U.S. Democracy Program of the Hewlett Foundation and the Arthur M. Blank Family Foundation, today the Center continues to thrive. Additionally, the Frank Batten School of Leadership and Public Policy as well as Vanderbilt University continue to support the work of the Center in meaningful ways.

Most noteworthy is a newly secured \$250,000 grant (for FY26 and FY27) from the U.S. Democracy Program of the Hewlett Foundation, which offers general program support and provides the most substantial resources for our congressional work. We have worked to deliver effectively on prior Hewlett grants and we have met all financial and reporting requirements.

We have begun to use the \$1.5-million three-year grant (FY25 through FY27) from the Arthur M. Blank Family Foundation to support our state lawmaking effectiveness work. This grant is allowing us to finalize the development of our State Legislative Effectiveness Scores, to continually update those scores at the conclusion of each legislative term, to make them available on websites for broad consumption, to build a research community around the use of these scores and around effective lawmaking in the states more generally, to build connections to media in the states to focus on effective lawmaking, to generate a New Member Guide for all newly elected state legislators, and to pilot some programming for existing lawmakers in various states (starting with Georgia and Montana, where the Blank Family Foundation focuses the bulk of their work).

As we continue to act on our 2023-26 Strategic Plan, the CEL is more confident than ever of the importance of its mission to enhance the effectiveness of individual lawmakers and U.S. legislative institutions. We continue to embrace our founding argument that "the search for effective lawmakers is perhaps as crucial as it has ever been. It is at times when institutions are failing that effective leaders are needed more than ever." (Volden & Wiseman, 2014, p. 13). We are proud of what we have accomplished thus far, and look forward to the work we have in store in the future.
